TENDER NOTICE

Director General, National Investigation Agency, 7th Floor, NDCC-II, Jaisingh Road, New Delhi invites sealed tenders on Tender Enquiry for award of Comprehensive Annual Maintenance Contract of Desktop computers, laptops, printers and other IT equipments (as per details mentioned at Annexure-I). Envelopes should be sealed and super scribed as "Quotation for CAMC of Desktop computers, laptops, printers and other IT equipments for NIA Office" **containing two separate sealed covers – One containing "TECHNICAL BID" and another containing "FINANCIAL BID"**. The last date of receipt of sealed tenders is 07 June 2017 at 1400 hrs and the tenders will be opened on the same day at 1600 Hrs. A representative of the firm may participate in the bid opening procedures. The pre-bid meeting will be held at NIA HQ New Delhi on 31st May 2017 at 1100 hrs.

2. **SUBMISSION OF BIDS** :- The Bid, in the prescribed format in a sealed cover, duly superscribed "Quotation for CAMC of Desktop computers, laptops, printers and other IT equipments and addressed to the Deputy Inspector General (Adm), National Investigation Agency, 7th Floor, NDCC-II, Palika Kendra, Jaisingh Road, New Delhi-01 should be sent by Registered Post or be deposited in the Tender Box kept at Main Reception Gate, 7th Floor, NDCC-II, Palika Kendra, Jaisingh Road, New Delhi-01, not later than 1400 hrs on 07/06/2017, containing two separate sealed covers – One containing "TECHNICAL BID" and another containing "FINANCIAL BID".

2.1 **TECHNICAL BID** :- First sealed cover super scribed as "TECHNICAL BID for "CAMC of Desktop computers, laptops, printers and other IT equipments for NIA Office" should contain following documents:-

- a) VAT / Sales Tax Registration Certificate along with TIN Number and Latest VAT / Sales Tax Clearance Certificate.
- c) Earnest Money Deposit for Rs.30,000/- (Rupees Thirty Thousand only).
- d) Documents regarding annual turnover of the firm & IT return for the last three financial years.
- e) List of Ministries / Government Departments to whom the AMC of items mentioned in Annexure-I was done.
- f) The firm must have the OEM product support capability of the equipments and shall act as a single point of support contact for the products. A certificate from OEM in this regard should be attached.



2.2 **FINANCIAL BID :-**

Second sealed cover super scribed as Desktop computers, laptops, printers and other IT equipment's for NIA Office" should contain price schedule, duly signed and stamped in the prescribed format (Annexure-1). Unstamped and / or unsigned Bids will not be entertained. The price bid should be in the same format as per Annexure – I **(Without VAT)** and the percentage of VAT to be mentioned separately against the quoted price.

- 2.3 The bidders should quote their unconditional rates, strictly as per the tender format. Cutting / overwriting, if any, should be countersigned.
- 2.4 The tenderer has to quote the rates of each of all the items mentioned in Annexure – I otherwise, the Financial Bid would not be considered by the department.

3. **OPENING OF THE BIDS**

- 3.1 The Technical Bids will be opened on 16:00 Hrs on 07th June 2017 at Conference Hall, 7th Floor, NDCC-II, Palika Kendra, Jaisingh Road, New Delhi in the presence of the bidders or their representatives who may like to be present and will be evaluated by a competent committee or authority.
- 3.2 Financial Bids of the eligible/technically qualified bidders will be opened on a later date for evaluation by a competent committee or authority. The date, time and venue for opening of financial bids will be informed later.
- 3.3 Late Bids: Bids received after the specified date and time will not be considered.

4. **EARNEST MONEY DEPOSIT (EMD) / BID SECURITY**

- 4.1 EMD of Rs.30,000/- (Rupees Thirty Thousand Only) in the form of demand draft from any commercial bank, payable in favour of the Pay and Accounts Officer, NIA (MHA), New Delhi, must accompany the Technical Bid. The Bid Security should be valid for one year. The Tenders received without EMD/Bid Security will be summarily rejected.
- 4.2 The firms registered with DGS&D/National Small Industries Corporation (NSIC) /Ministry of Home Affairs for above purpose only are exempted from depositing bid security. However, they have to enclose valid registration certificate (s) with their tender in a sealed envelope superscribed "BID SECURITY DEPOSIT".
- 4.3 EMD of all the unsuccessful bidders will be returned after finalisation of the contract.
- 4.4 The amount of BG or amount remitted towards Bid Security is liable to be forfeited if the tenderer resides from the offer after submission of the tender or



after the acceptance of the offer by the department or fails to sign the contract or to remit the Performance Security Deposit.

- 4.5 No interest will be paid by the department on the Bid / Performance Security deposited /remitted.

5. PERFORMANCE SECURITY

- 5.1 The successful bidder will have to furnish **10% of the total cost of the AMC as Performance Security** in the form of Demand Draft or in the form of Bank Guarantee/FDR from any of the commercial bank, in favour of the Pay and Accounts Officer, NIA, (MHA), New Delhi, within 15 working days of the award of the contract.
- 5.2 The performance security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the vendor.
- 5.3 Performance Security will be refunded to the supplier without interest after 60 days on completion of the contract in all respect.
- 5.4 Performance Security will be forfeited if the firm fails to perform any of the terms or conditions of the contract.

6. Period of Validity of Tender

The tender will remain valid for one year after finalization of the contract. The rates quoted will remain in force for the full period of contract. No demand for revision of rate on any account shall be entertained during the contract period. It will be open to the DG NIA to extend the term agreement for a further period, if necessary.

7. Evaluation

The evaluation and comparison of responsive bids shall be done on the basis of rates quoted per unit to NIA as per Annexure-I. The evaluation will be done on the lowest quote of the charges per unit to determine the L1 bidder.

8. Other terms and conditions

- a) The firm should be in existence for over 3 years in the trade with the maintenance business of more than Rs. 10 lakhs per annum during the last three years.
- b) One service engineer will be made available at NIA HQ daily from 09.30 AM to 06.00 PM.
- c) The firm must have previous experience in maintaining minimum 02 Nos of Servers/Storages in Govt organizations/PSU's. Performance certificates from the existing Govt clients must be attached.
- d) The firm must have expertise in the requisite preventive measures on site maintenance (FSMA).
- e) The AMC shall be on comprehensive maintenance service basis i.e. no extra charges for any spare parts etc will be paid. Any conditional tenders will not be considered.



- f) In case of intermittent failure and repetitive problems due to improper diagnosis or repair the system will be treated as continuously down.
- g) The vendor will provide engineer on all the days. The engineers should be equipped with Mobile phones to ensure their availability.
- h) The firm will prepare separate log books for above cited machines to be taken under AMC with special cleaning of the machines from outside and inside with liquid cleaner will be carried out on monthly basis. A preventive maintenance report from the user would be submitted to this office failing which an appropriate penalty would be imposed. The quarterly payment will strictly be made on the basis of satisfactory report from the user.
- i) The service engineers would take up any reported fault within 2 to 4 hours. As far as possible, the repairs would be carried out on site itself. However, in case the machine is taken to the workshop, the firm will also provide maintenance and repair services on holidays in case of emergency.
- j) If the machine is not repaired within three days, the firm will provide a standby machine within 1 day failing which a penalty of Rs.500/- (Rupees five hundred) only per day or part thereof will be charged for delay till such time machines are repaired. In case the parts that require replacement, is not available, the same should be replaced with a higher level of part that is compatible with the system.
- k) It may also be noted that in case of contractor backing out in midstream without any explicit consent of this office, the firm will be liable to recovery a higher rates, vis-a-vis, those contracted with it, which may have to be incurred by this office on maintenance of servers for the balance period of contract through alternative means.
- l) The above act of backing out would automatically debar the firm from any further dealing with this office and the EMD amount/security deposit would also be forfeited.
- m) No advance payment in any case would be made. However, quarterly payment after completion of each quarter would be made on production of bill/invoice (in triplicate) duly pre-receipted alongwith the satisfactory reports from the concerned user after deduction of applicable taxes.
- n) The contract can, however, be terminated by the office at any time if there are reasons to do so. If the work of the contractor is found to be unsatisfactory and the contract is entrusted to any other party at the risk and expenses of the defaulting contractor, the contract is liable to be cancelled.
- o) The firm must be ISO 9001: 2000 certified for AMC of computers and laptops.
- p) The firm must be authorized service provider of at least two reputed manufacturers of PCs & Laptops like HP, Sony, IBM, DELL, valid certificate to be attached preferably HP and DELL.
- q) The firm should be in the business of maintenance of computers, laptops, printers, scanners for at least 3 years (upto 2016) – (Requisite documents to support this claim will have to be produced in original for verification)
- r) The firm should have experience in AMC of at least 100 computers systems in each year during the last three preceding years.



- s) The firm should have registered in Provident Fund/ESI Departments of Central/ State Govt.
- t) List of Hardware engineers on the rolls of the firm with qualification and experience should be given.
- u) The address of the workshop with telephone numbers and Fax Nos. in Delhi/ New Delhi should be given.
- v) The contract will be on comprehensive basis inclusive of repairs and replacement of spare parts without extra payment. The contract will be effective for a period of one year from the date of issue of letter awarding contract. No demand for revision of rates on any account shall be entertained during the contract period. The contractor shall be responsible for any loss or damage caused to any of the machines owing to negligence on their part. The contractor will be required to keep virus – free computer environment in the NIA.
- w) All the computers and laptops shall be thoroughly inspected by the firm within 7 days of the award of the contract and estimates for pre-maintenance / repairs, if any, submitted within 7 days of the award of the contract. The NIA shall not bear any cost on repairs of equipments after the contract has been awarded.
- x) Sufficient number of Qualified Hardwar engineer, full time resident engineers shall be deputed to the NIA on every working day (working hours: 9:30 a.m. to 6.00 p.m.) including Saturday and if required by NIA even on Holiday / beyond working hours. The required number of engineers deputed on site may be mentioned in tender document submitted by the firm. The engineer should be equipped with mobile phone to ensure their availability. He will report to IT division on every day morning and will be available there throughout the working hours. If any engineer is required to take leave, a suitable replacement would have to be provided by the firm and intimated to us in advance.
- y) A register will be maintained in the IT division for recording the complaints by AMC engineer. The engineer will maintain a daily record of complaints received/ attended / not attended.
- z) The contractor shall arrange to get the character and antecedents of the worker verified from Police authorities before their deployment and their full particulars should be furnished to the NIA for the purpose of entry passes.
- aa) The Resident Service Engineer provided by the firm shall not be changed frequently. However, if found incompetent by the NIA then the Resident Engineer shall be changed by the firm immediately.
- bb) Additional Engineer may be deputed at NIA in addition to Resident Engineer whenever there is more workload/complaints/ emergency to rectify the equipment within stipulated time. This is to ensure the complaint is rectified the same day.



- cc) The machines are required to be repaired in NIA office premises only. In exceptional cases when the machine cannot be repaired in the office premises and required to be taken to the workshop, the NIA will not make any payment towards cartage and the expense for the to and fro transportation of the machines which shall be borne by the firm concerned. The equipment being taken to the workshop for repair would be at company's own risk and expenses. Any damage or loss caused to the computer / laptop or their part due to negligence, mishandling shall be made good by the company either by payment in cash the prevailing market price of that items or by a new one of the same make specifications.
- dd) It shall be the responsibility of the firm to make all the desktop computers, Laptops, Printer, scanner, Server, UPS and other IT equipment's work satisfactorily throughout the contract period and to hand over the systems in working conditions to the NIA after expiry of the contract. In case any damage is found, the firm is liable to rectify it even after the contract.
- ee) The firm shall obtain satisfactory service certificate from IT division before processing the payment. (Performa is attached)
- ff) Only genuine spare parts shall be used by the firm
- gg) Comprehensive AMC also to include maintenance services for OS, MS office, Anti-virus, software installation, installation of patches, pre-emptive actions against virus spread, detection/ removal of virus, configuration of internet, configuration other hardware and any other application software. The NIA will provide these softwares and their upgrades. Comprehensive AMC includes replacement of all spare parts including that of Mouse, keyboard, connectors, RAM, Hard-disk, wires, USB cables, Power cords and other parts related to printer, server, UPS, Laptop etc.
- hh) In case of replacement of faulty hard-disk, the hard-disk shall not be given to the firm.

Service Assurance:

- (a) A logbook shall be maintained in which the resident engineer shall record all the complaints made. They shall attend to all the complaints received immediately as follows:
- (i) Minor faults immediately (within three hours)
 - (ii) Major faults with 24 hrs by replacement method of providing standby arrangement.
 - (iii) The replacement of components, assemblies shall be as per manufacturer's instructions and under the orders of IT head.
 - (iv) The firm shall be responsible for taking back up data and programme available in PC before attending the fault and shall also be responsible for reloading the same. The back up copies to be returned to the users, under acknowledgement.
 - (v) The firm shall maintain the equipments and shall use genuine/ original components for replacement wherever needed. Until and unless written



order of the head of IT is conveyed, the original specification/ characteristics / features shall not be changed or modified under any circumstances.


- (vi) The firm shall also be responsible for deployment of necessary staff for regular cleaning of all hardware using suitable cleaning material and equipment to be arranged by the firm. Each equipment has to be cleaned **once in three months regularly**. A register shall be maintained showing the cleaning of each equipment and shall be produced to the Division In-Charge for verification, after the job.
- (vii) The schedule of preventive maintenance shall be as follows:
- Cleaning of all equipment using dry vacuum air, brush, and soft muslin clothes
 - Running the test programme to ensure quality print/ date reliability.
 - Checking of power supply source for proper grounding and safety of equipment.
 - Ensuring the covers, screws, switches etc are firmly fastened in respect of each equipment.
 - Scanning of all types of virus and elimination and vaccination of the same.
 - Shifting of equipment within the building as and when required.

8. The rates quoted should be net and no discount, free services/offers will be considered.

9. Acceptance of offer for award of CAMC shall be the exclusive authority of the Director General, NIA. Evaluation criteria will not only have the expensive financial condition, registration with authorities as criteria, but will also be considered on the quality of work to be promised.

10. The bidder/firm can visit NIA HQ New Delhi to ascertain the year, make, configuration of equipments/machines before submitting their technical and price bid.

11. The Head of Department reserves the right to reduce or increase the number of items offered for maintenance contract during the currency of the AMC.
