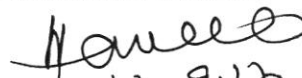

AUCTION NOTICE

A Public Auction of the condemned vehicles and unserviceable stores including electronic items (as per list enclosed) will be held on 5th October, 2017 at 1200 hrs in the Basement-II of NDCC-II, Building, (Near Palika Kendra) Jai Singh Road, New Delhi-100 001 on "As is where is" basis.

2. General public and interested parties are hereby invited to participate in the auction event at the specified date, time and place. The condemned vehicle and unserviceable store may be inspected on any working day during office hours between 03.00 PM to 05.00 PM. Shri Varun Kumar, Inspector (Mob No.9416790533) and Shri. Chaudhary Ram, ASI/MTO, Mob. No.9654073333) may be contacted for prior appointment. Please carry a valid ID while visiting the office. The terms and conditions of the auction are as under:-

- (i) An individual or any registered organisation (duly authorizing an individual) may participate. Individual should be a citizen of India and should be eligible to enter into contract as per law of the Land.
- (ii) Original Identity proof along with a photocopy of the same shall be produce by the participants. (acceptable Identity proof: Aadhar card, Voter-ID, PAN Card, Passport or any other photo ID card issued by the Central/State Govt. or PSUs).
- (iii) Participants are required to deposit a sum of Rs.10,000/- (Rupees Ten Thousand only) in cash or in the form of DD/Banker's Cheque etc. as Security Deposit and to register their name with the designated Board for Auction before start of the Auction.
- (iv) The above Security Deposit of the unsuccessful bidder will be refunded after the completion of auction process.
- (v) Successful bidder will be decided on the basis of the highest bid made by the bidders.
- (vi) The successful bidders have to deposit 25% of their bid amount immediately in the form of DD/ Banker's Cheque immediately after completion of bid.
