Clarification for specification of Bullet Proof Jackets & Vests

M/s SMPP Pvt. Ltd., New Delhi has raised certain queries related to procurement of BP Jackets and Vests vide NIA tender dated 11.09.2018. The query raised and the reply is appended below: -

01.	<p><u>BFS (Trauma) 25 mm:</u> It is to bring to your kind notice that there will be significant further increase in the weight of the BR Jackets in case BFS of 25mm is desired. This will also make the jackets very uncomfortable as thickness of Soft Armor Panels (SAP) will be very high. Further, increased weight and high thickness will severely compromise the agility and maneuverability of the soldier. That is why even BPR&D preferred to keep the required BFS as 44mm for Level-IV protection BR Jackets and complete given specification is thus designed accordingly. We therefore request you to keep required BFS (Trauma) as 44mm as given in BPR&D specification.</p>	<p>The requirement of Back Face Signature (BFS) is 25mm and the same is required to be provided by the successful bidder.</p>
02.	<p><u>BFS measurement for shots:</u> We understand that BFS will be measured for only 1st 02 shots only as it is done for Level III+BR Jackets as per BPR&D specification. Kindly confirm the same.</p>	<p>The testing of BFS will be carried out as per the criteria mentioned for Level-III+ BR Jackets by BPR&D specifications.</p>
03.	<p><u>Sample requirement:</u> We were informed that samples will be required for evaluation. We wish to inform you that we need at least 02 weeks to prepare samples for submission.</p>	<p>Samples will be required for evaluation.</p>
04.	<p><u>Dynamic Weight Distribution System:</u> Please confirm if you require the same. Generally, it is useful for forces on patrolling assignment or area domination exercise. In case you need the same, we will need extra 02 weeks to prepare and offer the same in samples.</p>	<p>Dynamic weight distribution system has not been asked vide tender QRs.</p>
