AUCTION NOTICE


A Public Auction of the condemned vehicles and unserviceable stores including electronic items (as per list enclosed as Annexure -A & B) will be held **on 07 August, 2019 at 1100 hrs** in the Basement-II of NIA Building (Near JLN metro station) opposite CGO Complex, Lodhi Road, New Delhi-110003 on "As is where is" basis.

2. General Public and interested parties are hereby invited to participate in the auction event at the specified date, time and place. The condemned vehicle and unserviceable store including electronic items may be inspected on any working day during office hours between 03.00 PM to 05.00 pm. Shri Mahender Singh Rathore, Inspector. (Mob No 9717371926) may be contacted for prior appointment. Please carry a valid ID while visiting the office premises.

3. The terms and conditions of the auction are as under:-

- (i) An individual or any registered organization (duly authorizing an individual) may participate. Individual should be a citizen of India and should be eligible to enter into contract as per law of the Land.
- (ii) Original identity proof along with a photocopy of the same shall be produce by the participants. (acceptable identity proof: Aadhar card, Voter-ID, PAN card, Passport or any other photo ID card issued by the Central/State Govt. or PsSU).
- (iii) Participants are required to deposit a sum of Rs. 10,000/- (Rupees Ten Thousand only) in cash or in the form of DD/Banker's cheque etc. as security Deposit and to register their name with the designated Board for auction before start of the Auction.
- (iv) The above Security Deposit of the unsuccessful bidder will be refunded after the completion of auction process.
- (v) Successful bidder will be decided on the basis of the highest bid made by the bidder(s).
- (vi) The successful bidders have to deposit 25% of their bid amount in the form of DD/ Banker's Cheque immediately after completion of bid. Security Deposit of Rs. 10,000/- mentioned above will be refunded to successful bidder after submission of the 25% of their bid amount referred above. In case bidder failed to deposit the requisite amount in specified time the security deposit will be forfeited and bidder will not be allowed to participate in the further auction.

- (vii) Balance amount by successful bidder required to be submitted within 3 days after the bid. In case the bidder failed to submit the balance amount within specified time, the amount already deposited will be forfeited.
- (viii) The items/vehicle will be handed over after depositing the full amount. Auctioned items/ vehicles are to be removed from office premises within one day after depositing the full amount failing which penalty of Rs. 100/- per day will be levied.
- (ix) GST will be charged extra as per applicable rates.
- (x) NIA staff and their family members are not allowed to participate in this (family members means-wife/husband, father, mother, children, their spouse, brother/sister and their spouse).
