


APPLICATIONS/ WILLINGNESS FOR ENGAGEMENT OF EXPLOSIVE EXPERT

NIA is looking for competent retired Government officers having requisite qualifications and experience who are keen to work in Agency as Explosive Expert on contractual basis at NIA Hqrs, New Delhi and its branch offices Hyderabad, Mumbai and Chandigarh at a fixed monthly remuneration i.e. last pay drawn minus pension initially for a period of 01 year which can be extended further as per mutual consent. They will not be entitled to any other allowance like House Rent Allowance, Medical reimbursement, Leave Travel Concession etc. However, they will be entitled to TA/DA as payable to their counterparts in the regular cadre of NIA. The person so engaged shall have no right to claim regularisation/ absorption in the organisation after the expiry of period of contract.
