
**Empanelment of Special Public Prosecutors for representing cases of National Investigation Agency.**

National Investigation Agency intends to empanel counsels well versed with Criminal Law and Procedures to represent the State through NIA in Special Courts, High Courts and to conduct prosecution/appeals/revisions/Writ Petitions etc. on behalf of NIA in the various States and Union Territories.

2. A person empaneled shall be notified as Special Public Prosecutor under Section 15 of the NIA Act, 2008 read with Section 24(8) of Cr. P. C. by the Central Government in a State /UT for the purpose of prosecuting cases instituted by the NIA in the Special Courts and various High Courts constituted under the law. A person shall not be qualified to be appointed as a Special Public Prosecutor unless he has been in practice as an Advocate for a period of not less than ten years or has held any post, for a period of not less than ten years, under the Union of a State, requiring special knowledge of law. In nutshell, advocates having adequate experience in conducting criminal cases in Courts may only apply. The terms and conditions will be as per the guidelines fixed by Ministry of Home Affairs/ Ministry of Law & Justice, Department of Legal Affairs, Government of India. The applicant should apply in Proforma which may be downloaded from NIA website.
