

(i) Stenography speed: 10 mts @ 80 words per minute.

(ii) Transcription: 50 minutes (English), 65 minutes (Hindi) on computer.

Note-1: Qualifications are relaxable at the discretion of the Staff Section Commission or competent authority, for reasons to be recorded in writing, in case of candidates otherwise well qualified.

Note-2 : The qualification regarding experience is relaxable at the discretion of the Staff Selection Commission of competent authority, for reason to be recorded in writing, if case of candidates belonging to Schedules Castes or Scheduled Tribes, if at any stage of selection the Staff Section Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

NOTE- 3: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation or absorption. Similarly, deputationinsts shall not be eligible for consideration for appointment by promotion.

NOTE- 4: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in same or some other organization or department of the Central Government shall ordinarily not to exceed three years'.

NOTE- 5: The maximum age limit for appointment by deputation shall not be exceeding 56 years' as on the closing date of receipt of applications.

NOTE- 6: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 01.01.2006 or the date from which the revised pay structure based on the 6th Central Pay Commission recommendation has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay

		into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which the grade pay or pay scale is the normal replacement grade without any upgradation.
