### **4<sup>th</sup> Supplementary Charge Sheet filed in Burdwan Blast case**

On 10.04.2017, the National Investigation Agency filed the 4<sup>th</sup> supplementary charge-sheet has been filed before the Ld. Spl. NIA Court, Kolkata, against three accused persons, namely, 1) **Mohammed Rubel @ Mohammed Liakot Ali Pramanik @ Rafiq @ Mohammad Rafiq Sheikh @ Zakir Hussain Sk. @ Rafique @ Rafiqul Islam**, son of Mohammed Zayeed Hussain Pramanik, resident of village Boiloshing Police Station Baghmara, Rajshahi, Bangladesh, who also resided at Vill. Kamurdiar, PS: Domkal, District Murshidabad, West Bengal, 2) **Jahidul Islam @ Habibur Rahman @ Jahidul @ Jabirul Islam @ Zafar @ Jahidul @ Habib**, son of Jahir Ahmad Tahir Sikdar, resident of village Putiajani, Police Station Delduar, Putiajani Bazar, District Tangail, Dhaka Division, Bangladesh, who also resided at Vill. Saffarbari, PS: Sarthebari, District Barpeta, Assam, and 3) **Sahidul Islam @ Samim @ Shamim @ Asraful Alam @ Nirmal @ Surjo**, son of Jahruddin @ Sarkar, resident of village Rawmaripathar, PS: Bohuri Tarabari, District Barpeta, Assam, in connection with NIA Case No. RC-03/2014/NIA/DLI (Burdwan Blast Case) under relevant sections of IPC and the Unlawful Activities (Prevention) Act, 1967, and the Foreigners Act, 1946.

2. All the above mentioned accused were arrested in connection with STF PS, Kolkata Police, Case No. 11/2016, dtd 25.09.16, and were taken on police remand in connection with the instant NIA Case on 25.10.2016, along with two other accused persons, who were already charge-sheeted in this case.

3. The said accused persons, being members of the terrorist organization, Jamat-Ul-Mujahideen, Bangladesh (a proscribed terrorist organization in Bangladesh), which was responsible for the Burdwan Blast, associated themselves with other members of the JMB in terrorist activities and criminally conspired with the arrested as well as absconding co-accused to carry out subversive activities like collection of funds, recruitment of vulnerable Muslim youths into the fold of JMB, imparting training to them and motivating them to make hand-made weapons like bows and arrows, etc., radicalizing them to fight against members of other communities within India as well as waging war against an Asiatic power in alliance with the Government of India.
