Charges framed against all accused in Bharuch Double Murder Conspiracy case

NIA had registered a case no. RC-13/2015/NIA/DLI under sections 13, 17 & 18 of UA(P) Act, 1967 and section 302, 450, 120(B), 121, 121-A, 153-A, 114, & 34 of IPC, section 25(1)A, 25(1)AA & 27, 29 of Arms Act and Section 135 of Gujarat Police Act, as per directions of Ministry of Home Affairs, Government of India, relating to murder of two persons belonging to a particular section of society on the allegation that on 2nd November 2015 at Bharuch, Gujarat, two unidentified assailants came on a motor cycle and fired two rounds from a revolver, one on Shirish Bengali and another on Pragnesh Mistry with injury in his stomach and later fled from the scene. Both the persons died of firearm injuries. This attack was intended to strike terror in the minds of people.

2. NIA, Mumbai had submitted chargesheet against 10 accused on 07/05/2016 before the NIA Special Court Ahmedabad in this case u/s Section 16, 17, 18, 20, 23 of the Unlawful Activities (Prevention) Act 1967, U/s 120-B, 302, 114, 153-A, 449, 201 of the Indian Penal Code 1860; Sections 25(1B)a, 27(1) of the Arms Act; and Section 135 of Gujarat Police Act.

3. Further, NIA, Mumbai had submitted a supplementary chargesheet on 19.08.2016 against wanted accused Zahidmiya @ Jao, s/o Saeedmiya Munshi Saikh.

4. On 26/07/2018, NIA Special Court Ahmedabad has framed charges against following 10 arrested accused persons under various sections of UA(P) Act, IPC and local laws :
