## RC-03/2018/NIA/LKW, Arms Snatching case

NIA, today (11.04.2019) filed Charge Sheet in Case RC-03/2018/NIA/LKW, which relates to looting of service weapons from two Police personnel from Khala-Kamalpur Check Post, PS Jhinhana, District Shamli, UP on 02.10.2018. Initially, a case FIR No. 723/2018 dated 03.10.2018, u/s 395, 397 & 412 of IPC section 27 of Arms Act and sections 13, 16, 18 and 20 of UA (P) Act was registered by Uttar Pradesh Police at PS Jhinhana, Shamli. This Case was subsequently taken over by NIA for investigation.

2. On 15.10.2018, three accused persons namely Gurjant Singh @ Jinta son of Kulwant Singh, resident of village Dhalavali, PS Gangoh, Saharanpur, Uttar Pradesh, Karam Singh son of Late Gurcharan Singh, resident of Village+Post Rangana Farm (Rangana 2) PS Jhinhana, District Shamli, U.P and Amrit Singh @ Amrat, Son of Palla Singh, resident of Gali No. 02, Sector 6, Vikas Nagar, PS Sadar, Karnal, Haryana were arrested by the UP Police and looted service weapons and ammunitions were recovered from their possession after an encounter. On 18.10.2018, accused Karamveer Singh @ Karma son of Ajit Singh, resident of village Ajijpur, PS Jhinhana, District Shamli, U.P was arrested by UP Police and 01 illegal firearm and some ammunition were recovered from his possession. Also, on 18.10.2018, accused Jarman Singh @ Garman Singh, son of Sh. Kulwant Singh, resident of village Ajijpur, PS Jhinhana, Shamli, U.P was arrested by Punjab Police. Four Country made firearms and ammunition were also seized at the instance of accused Jarman Singh on 22.10.2018.

3. During investigation, it was found that the arrested accused Jarman Singh and others looted service weapons from Police personnel with an intention to further use these weapons to eliminate a senior political leader of Punjab due to ideological and religious fanaticism. It came on record that Jarman Singh was highly motivated and radicalized to the cause of Khalistan. He not only used to share Khalistan related videos with his friend circle but he was also associated with a number of people of same ideology through various social media platforms. He is fanatic to the core and hence got upset with the news of desecration of Gurugranth Sahib. He tried to arrange automatic illegal weapons through various channels i.e. by soliciting the same from different people but after having failed in his quest, he thought to use the illegal weapons he had. He tried to practice fire with .30 bore country made pistol watching Youtube videos. After having failed in his attempts to obtain weapons of his desire and requirement, he carried out this incident in association with his associates.

Jarman Singh was also a member of a Whatsapp group named Referendum2020 where they used to discuss about formation of Khalistan.

4. Charge Sheet has been filed in the Special NIA Court, Lucknow, U.P against (i) Gurjant Singh @ Jinta, (ii) Jarman Singh @ Garman Singh, (iii) Karamveer Singh @ Karma, (iv) Karam Singh and (v) Amrit Singh @ Amrat u/s 120 B, 307, 392 and 397 read with 34 of IPC, section 27 of Arms Act and sections 13(1), 16, 18 and 20 of UA(P) Act.

5. Further investigation continues u/s 173(8) CrPC.
