## 2. JUDICIAL INFORMATION

**Summary of Facts of the Case:** INDIA, Punjab: On 01 January 2016

Case RC-03/2016/NIA/DLI. On 1st/2nd January, 2016, members of proscribed terrorist organisation Jaish-e-Mohammad, under the leadership of Maulana Mohamad Masood Azhar along with the subject Shahid Latif, Jan Ali @ Kashif Jan and Abdul Rauf conspired and executed a terrorist attack on Pathankot Air Force Base in India killing 8 innocent Indian citizens and injuring 38 others.

**Additional Facts of the Case:** Heavily armed terrorists of Jaish-e-Mohammad (whose chief is Maulana Mohamad Masood Azhar Alvi and senior leaders are Abdul Rauf, Jan Ali @ Kashif Jan and Shahid Latif) infiltrated into the Indian territory. The terrorists abducted one Indian citizen, along with his vehicle and later killed him brutally. Thereafter, they again abducted 3 Indian citizens, along with the vehicle and after inflicting lethal injury to one of them, they abandoned their vehicle and launched an attack at Pathankot Air-Force Station in the intervening night of 1st and 2nd January 2016. During the gun battle, all the terrorists were neutralized by the Indian security forces. In the gun battle, one civilian was killed, 7 army personnel were martyred and 38 others were injured.

### ARREST WARRANT OR JUDICIAL DECISION 1

**Charge:** Punishment for murder, Attempt to murder, Waging, or attempting to wage war, or abetting waging of war, against Government of India, Conspiracy to commit offences punishable by section 121 of Indian Penal Code i.e. waging, or abetting waging of war against Government of India, Assaulting the President, Governor, etc, with intent to compel or restrain the exercise of any lawful power, Want only giving provocation with intent to cause riot, Punishment for criminal conspiracy, Punishment for certain offences regarding illegal arms and ammunitions, Punishment for conspiracy, etc for terrorist act, Punishment for being member of terrorist gang or organization, Offence relating to membership of a terrorist organization, Punishment for causing explosion likely to endanger life or property, Punishment for attempt to cause explosion, or for making or keeping explosive with intent to endanger life or property.

**Law Covering the Offence:** Section 302, 307, 121, 121A, 124, 153 read with 120B of Indian Penal Code, Section 25 of Arms Act, Section 18, 20, 38 of Unlawful Activities (Prevention) Act, and Section 3 and 4 of Explosives Substance Act.
