Subject is a member of proscribed terrorist organization, Hizb-ul- Mujahideen (HM), in India. He illegally crossed over the Indian borders from Jammu and Kashmir and underwent terrorist training in Pakistan. He is involved in raising funds in Pakistan and other countries and sending it to India through hawala channels for its use in terrorist activities by the cadre of Hizb-ul-Mujahideen.
