Four terrorists of The Resistance Front (TRF), a frontal outfit of proscribed terrorist outfit Lashkar-e-Taiba(LeT), are wanted by the National Investigation Agency in connection with NIA Case RC-32/2021/NIA/DLI related to conspiracy hatched for radicalising, motivating and recruiting youth of Jammu & Kashmir to effect violent activities in Jammu & Kashmir and rest of India.
