NIA Special Court, Bilaspur Convicts and Sentences Seven Accused in Janjgir Champa FICN Case of Chattisgarh (RC-01/ 2019/NIA/RPR)

Yesterday (30.06.2022), NIA Special Court, Bilaspur convicted and sentenced 7 accused persons in RC-01/2019/NIA/RPR.

2. The case was related to the seizure of Fake Indian Currency Notes amounting to Rs-7,39,300/-, stamp papers and other material objects from the possession of accused persons. On the disclosures of the accused persons, huge amount of FICN was seized from the accused persons.

3. The case was initially registered by Hasoud PS of Janjgir-champa district as FIR No. 101/2019 dated 20.06.2019 which was re-registered by NIA on 09.08.2019. After investigations, NIA had filed a Chargesheet against the accused persons on 08.09.2020.

4. The details of these convicts are given as below:

- 1) Devendra Chandra @ Devendra Kumar Chandra S/o Balram Chandra R/o village Kirirada, PS Birra, Dist.- Janjgir Champa, Chattisgarh to Rigorous Imprisonment for 7 years under sections 489A, 489B, 489C and 120B of IPC with Fine of Rs. 5000/- in each offence.
- 2) Manoj Sahu @ Manoj Kumar Sahu S/o Rajkumar Sahu R/o village Karhi, PS Birra, Dist.- Janjgir Champa, Chattisgarh to Rigorous Imprisonment for 7 years under sections 489A, 489B, 489C, 489D and 120B of IPC with Fine of Rs. 5000/- in each offence.
- 3) Rohit Bharadwaj @ Rohit Kumar S/o Ramdas R/o Village Tundra, PS Gidhauri, Dist. Baloda Bazar, Chattisgarh to Rigorous Imprisonment for 7 years under sections 489A, 489C and 120B of IPC with Fine of Rs. 5000/- in each offence.
- 4) Dilip Mahilange @ Dilip Kumar Mahilange R/o village Khokhali, PS-Bhatapara Grammeen, Dist.- Baloda Bazar, Chattisgarh to Rigorous Imprisonment for 7 years under sections 489A, 489C, 489D, 255, 256, 259 and 120B of IPC with Fine of Rs. 5000/- in each offence.
- 5) Doman Miri @ Doman Singh Miri S/o Rajkumar Miri R/o village Khokhali, PS-Bhatapara Grammeen, Dist.- Baloda Bazar, Chattisgarh to Rigorous Imprisonment for 7 years under sections 489A, 489C, 489D and 120B of IPC with Fine of Rs. 5000/- in each offence.
- 6) Nohar Sinha S/o. Kejuram SInha R/o village Datan PS Palari, Dist.- Baloda Bazar, Chattisgarh to Rigorous Imprisonment for 7 years under sections 489A, 489C and 120B of IPC with Fine of Rs. 5000/- in each offence.
- 7) Hemlal Sahu s/o Neel Chand Sahu R/o village Siladehim PS-Birra, Dist. Janjgir-Champa, Chattisgarh to Rigorous Imprisonment for 7 years under sections 489B and 120B of IPC with Fine of Rs. 5000/- in each offence.
