

Press Note

The National Investigation Agency, is investigating case No. RC-06/2012/NIA/DLI dated 10.09.2012 against the functionaries / members of the proscribed terrorist organisation Indian Mujahideen (IM). After the Investigation, 2 (two) Charge-sheets have been filed in the aforesaid case, against accused Mohd. Danish Ansari, Aftab Alam, Syed Maqbool, Imran Khan, Obaid-ur-Rahman, Mohd. Ahmed Sidibapa, Asadullah Akhtar, Manzar Imam and Ujair Ahmed.

The NIA had earlier moved the competent court for declaring the absconding accused persons including 1. **Md. Riyaz @ Riyaz Bhatkal**, 2. **Md. Iqbal @ Iqbal Bhatkal**, both residents of Bhatkal, 3. **Tahseen Akhtar @ Monu**, resident of Samastipur, Bihar, 4. **Amir Reza Khan**, resident of Gaya, Bihar, 5. **Mohsin Ismail Choudhary**, resident of Pune, Maharashtra, 6. **Dr. Shahnawaz Alam**, 7. **Ariz Khan @ Junaid**, 8. **Md. Sajid @ Bada Sajid**, 9. **Md. Khalid** and 10. **Mirza Shadab Beg**, all residents of Azamgarh, Uttar Pradesh, as Proclaimed Offenders and further prayed for the attachment of all movable and immovable properties owned by them, in order to compel them to surrender before the Hon'ble Court. Upon request made as above by the NIA, the Hon'ble District & Sessions Judge / Special Judge, NIA, Patiala House Court, New Delhi had issued Orders of Attachment of Property U/s 83 Cr. P. C against the above accused persons.

As per the orders of the Court, the NIA officers alongwith local police, visited the permanent residential addresses of the accused persons and identified movable and immovable properties owned by the accused persons as noted above and today, on 27.03.2014, the NIA has attached the immovable property – a residential **Flat at Kondhwa, Pune, Maharashtra**, along with all movable properties therein belonging to the absconding accused **Mohsin Ismail Choudhary @ Mohsin Choudhary** of Pune in Maharashtra.

Earlier this week in Azamgarh, Uttar Pradesh, the movable properties of the absconding accused persons namely, 1) **Dr. Shahnawaz Alam**, 2) **Ariz Khan @ Junaid**, 3) **Md. Khalid** and 4) **Mohd Sajid @ Bada Sajid**, were attached and are presently retained in Sarameer Police Station. The property of the accused Mirza Shadab Beg was found to have been already attached earlier in connection with Gorakhpur PS Cantt. Crime No. 812/2007.

These accused persons are a part of the larger conspiracy of the IM to wage terrorist activities within India, and apart from RC-6/2012/NIA-DLI, are also wanted for their involvement in several terrorist acts committed across the country.
