

PRESS NOTE

National Investigation Agency (NIA) solicits the cooperation and assistance of general public and requests to provide information leading to the arrest of the two operatives of the **Indian Mujahideen**, who are in hiding somewhere in India.

Tahseen Akhtar @ Monu @ Hassan and **Waqas @ Javed @ Ahmed** are wanted by the NIA for their role in the conspiracy furthered by the operatives of the Indian Mujahideen being investigated in Case No. **RC-6/2012/NIA/DLI** and for their roles in the commission of the **Hyderabad (Dilsukhnagar) Blasts dated 21.2.2013**.

The above named accused persons are also involved in the planning and commission of several terrorist acts including the blasts at **Varanasi** (2010), Serial Blasts at **Mumbai** (2011), Dilsukhnagar, **Hyderabad** (2013) and others. They may also be plotting for future terrorist strikes. Both the accused persons are known to be inciting communal hatred in society.
