10 NDFB(S) militants charge sheeted by NIA for involvement in violent killings of civilians in Kokrajhar, BTAD, Assam, in December'2014.

The NIA Guwahati Branch office, has submitted charge sheet against 10 (ten) hard-core terrorists of National Democratic Front of Bodoland (Songbijit) in connection with NIA case no. **RC-06/2014/NIA-GUW** pertaining to the incident of hostile acts at Lungsung area in Kokrajhar, Assam.

2. The involvement of the charge sheeted accused persons was established in the terrorist attack on 23rd December'2014 by NDFB(S) militants upon innocent people of Adivasi community in villages - Parganapur, Bollamguri and Dewalguri in Lungsung area under Kokrajhar Police Station, BTAD, Assam, resulting in death of 08 (eight) and causing grievous injury to 03 Adivasi people due to indiscriminate firing with sophisticated weapons.

3. The particulars of the charge sheeted accused persons are as follows:

- (i) **Philip Basumatary @ B. Pengkha** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.
- (ii) **Bipin Brahma @ B. Bindw** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.
- (iii) **Saronjoy Mushahary @ Daoha @ Soukhw** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.
- (iiii) **Sanjay Narzary @ Cyclum** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.
- (v) **Swmla Basumatary @ Sohitap** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.
- (vi) **Dhananjoy Daimary @ Dwisrang** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.
- (vii) **Lebow Basumatary, @ Libao Basumatary @ Lufar** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act and section 27 of Arms Act.
- (viii) **Libion Basumatary @ Loithinidinga @ B.L. Dinga** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.
- (ix) **Rajib Basumatary** for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.

(x) *Jwngblaw Narzary @ Jekhai* for his prosecution u/s 120B, 121, 121A, 302, 307, 326, 436 and 34 of IPC & sections 16,18, 20 of UA(P) Act.

4. The National Investigation Agency has till date arrested total 61 hard-core militants of NDFB(S) of different ranks in connection with the abysmal terrorist attacks upon innocent people of different communities in Assam in the month of May and December of 2014. With these 10 accused, the no. of NDFB(S) cadres charge sheeted by NIA till date stands at 55.

5. Further investigation of the case is continuing with the permission of the concerned court under the provision of section 173(8) CrPC to book certain hard-core and senior leaders of NDFB(S).
