16. **Brief facts of the case:**

16.1 The instant case was originally registered as FIR No. 558/2014 dated, 25/12/2014 of Kokrajhar Police Station, District Kokrajhar, BTAD, Assam. It was alleged that a group of banned NDFB(S) cadres hatched a criminal conspiracy and entered into the No. 3 xxxxxxxx village under Kokrajhar Police Station on 23.12.2014 at about 1740 hours and committed terrorist act by way of indiscriminate firing on innocent xxxxxxxx people of the village resulting in killing of 11 people and serious injury to 03 others with the intention to wage war against the Government of India.

16.2 After registration of the case at Kokrajhar Police Station, initially the investigation was conducted by Assam Police. Subsequently, in compliance of Ministry of Home Affairs,

Government of India Internal Security-I Division North Block, New Delhi vide order No. F. No.11011/66/2014-IS.IV, dated 27.12.2014, NIA has re-registered a case vide FIR No. RC-07/2014/NIA-GUW dated 30/12/2014 under sections 120B, 121, 121A, 122, 447, 326, 307, 302 of IPC, 27 Arms Act & 10, 13 of Unlawful Activities (Prevention) Act, 1967 arising out of Kokrajhar PS Case No. 558/2014 dated 30.12.2014.

- 16.3 During the course of investigation, it is revealed that 12 (twelve) numbers of villagers belonging to xxxxxxxxx community were killed and 3 (three) others were grievously injured as a result from indiscriminate firing with sophisticated deadly weapons at No 3 xxxxxxxxx village village, on 23/12/2014 at about 05.40 PM, by NDFB(S) militants. Among the victims killed in the incident, six were male and six were female. Another three were grievously injured and the injuries were inflicted by firearm bullets.
- 16.4 During the course of investigation by NIA, four accused persons namely Swmkwr Basumatary @ B. Sukhao (A-1), Rabi Basumatary @ B. Rongjabaja @ Rabi (A-2), Lwithw Brahma @ Lafa (A-3) and Willbe Rabha @ R. Hasong (A-4) were shown arrested by NIA on 09.10.2015, 19.11.2015, 03.02.2016 and 03.02.2016 respectively. Thereafter the final report of the case in the form of Charge Sheet was submitted before the Hon'ble Special Judge, NIA, Assam, Guwahati on 02.04.2016 against the above noted 04 (four) accused persons i.e. A-1, A-2, A-3, and A-4. All the above noted 04 (four) arrested accused persons are presently in Judicial custody at Central Jail, Guwahati, Assam. Thereafter, during further investigation, 03 (three) NDFB(S) cadres namely Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), Gangaraj Owary @ W. Gol @ Gangaraj Wary (A-6) and Lothen Basumatary @ Borai (A-7) were also shown arrested in connection with instant case on 06.04.2016. The said accused persons i.e. A-5, A-6 and A-7 are also presently lodged at Central Jail, Guwahati, Assam.

17 Facts Disclosed During Further Investigation:

- 17.1 The place of occurrence is in Kokrajhar district which comes under BTAD (Bodoland Territorial Areas District) Assam. The Bodoland Territorial Council (BTC) is a territorial privilege established according to the memorandum of settlement dated, 10th of February, 2003 entered into by outlawed Bodo Liberation Tigers (BLT), Government of India and Government of Assam. The BTC came into existence immediately after the surrender of BLTF (Bodo Liberation Tiger Force) cadres. The BTC has 12 electorate members, each looking after specific area of control called Somisthi. The area under the BTC jurisdiction is called Bodoland Territorial Areas District (BTAD). The BTC constitutes 70% of tribal people. The BTAD consists of 4 contiguous districts – Kokrajhar, Baksa, Udalguri and Chirang, carved out of 7 existing districts namely Kokrajhar, Bongaigaon, Barpeta, Nalbari, Kamrup, Darrang and Sonitpur. It is an autonomous administrative unit constituted under the sixth schedule of the Constitution of India.
- 17.2 Investigation had revealed that NDFB(S) carried out the carnage at village No. 3 xxxxxxxxx village under Kokrajhar Police Station. During further investigation, involvement of NDFB(S) cadres namely (i) Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), (ii) Gangaraj Owary @ W. Gol @ Gangaraj Wary (A-6) and (iii) Lothen Basumatary @ Borai (A-7) has surfaced. They, in connivance with other NDFB(S) cadres viz. (i) Swmkwr Basumatary @ B. Sukhao (A-1), (ii) Rabi Basumatary

@ B. Rongjabaja @ Rabi (A-2), (iii) Lwithw Brahma @ Lafa (A-3), (iv) Willbe Rabha @ R. Hasong (A-4) (v) Jarimin, (vi) Usaobadao @ Jathi, (vii) Jamphraw, (vii) Sujukhong, (ix) Jwthn @ Jailsing, and others under the command of I. K. Songbijit, G. Bidai and Batha killed twelve villagers belonging to xxxxxxxx community and injured three others and burnt the houses at No. 3 xxxxxxxx village under Kokrajhar district of Assam by using sophisticated weapons. Further, being NDFB(S) members they extorted money for NDFB(S) from various Central and State sponsored schemes, contractors etc. to raise funds in order to procure arms and ammunitions so as to wage war against the Government of India. NDFB(S) cadres are also involved in recruiting new cadres, threatening security forces etc.

- 17.3 Further investigation established that, on fateful day of 23.12.2014 at about 05.40 PM arrested accused Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), Gangaraj Owary @ W. Gol @ Gangaraj Wary (A-6) and Lothen Basumatary @ Borai (A-7) along with other NDFB(S) cadres viz. Swmkwr Basumatary @ B. Sukhao (A-1), Rabi Basumatary @ B. Rongjabaja @ Rabi (A-2), Lwithw Brahma @ Lafa (A-3), Willbe Rabha @ R. Hasong (A-4), Jarimin, Usaobadao @ Jathi, Jamphraw, Sujukhong, Jwthn @ Jailsing and others under the instructions of Songbijit Ingti Kathar @ I K Songbijit, Bishnu Goyari @ G. Bidai and Binod Mushahary @ M. Biban @ Batha killed twelve villagers belonging to xxxxxxxx community and grievously injured three others at No. 3 xxxxxxxx village, PS- Kokrajhar, district- Kokrajhar (BTAD), Assam by using sophisticated weapons. - 17.4 During the course of further investigation, it has been established that, the specific part of the larger conspiracy relating to the instant crime was hatched by accused (i) Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), (ii) Gangaraj Owary @ W. Gol @ Gangaraj Wary (A-6), (iii) Lothen Basumatary @ Borai (A-7), (iv) Swmkwr Basumatary @ B. Sukhao (A-1), (v) Rabi Basumatary @ B. Rongjabaja @ Rabi (A-2), (vi) Lwithw Brahma @ Lafa (A-3), (vii) Willbe Rabha @ R. Hasong (A-4), (viii) Jarimin, (ix) Usaobadao @ Jathi, (x) Jamphraw, (xi) Sujukhong, (xii) Jwthn @ Jailsing and others under the command of the senior military leadership of the NDFB (S) namely, Bishnu Goyari @ G Bidai, Binod Mushahary @ M Biban @ Batha and I. K. Songbijit.
- 17.5 Further investigation established that, the instant terrorist act committed upon innocent people of No. 3 xxxxxxxxxx village by accused persons namely (i) Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), (ii) Gangaraj Owary @ W. Gol @ Gangaraj Wary (A-6), (iii) Lothen Basumatary @ Borai (A-7), (iv) Swmkwr Basumatary @ B. Sukhao (A-1), (v) Rabi Basumatary @ B. Rongjabaja @ Rabi (A-2), (vi) Lwithw Brahma @ Lafa (A-3), (vii) Willbe Rabha @ R. Hasong, (A-4) (viii) Jarimin, (ix) Usaobadao @ Jathi, (x) Jamphraw, (xi) Sujukhong, (12) Jwthn @ Jailsing and other NDFB(S) cadres, on the instructions of the senior military leadership of the NDFB (S) namely, I K Songbijit, Bishnu Goyari @ G. Bidai and Binod Mushahary @ Batha were done in furtherance of conspiracy and unlawful goal of achieving total independence from Union of India by creating a sovereign Bodoland exclusively for xxxxx people of Assam. In order to threaten the unity, integrity, security or sovereignty of India, accused persons namely (i) Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), (ii) Gangaraj Owary @ W. Gol @ Gangaraj Wary (A-6), (iii) Lothen Basumatary @ Borai (A-7) and other co-accused persons executed the order given by other senior cadres of NDFB (S) namely, G. Bidai, I K Songbijit and Batha by means of spreading terror in the form of targeted killings of innocent people belonging to xxxxxxxxxx community to further the cause of their organisational commitment.
- 17.6 Further investigation has established that, the instant incidents at No. 3 xxxxxxxxxx village under Kokrajhar Police Station, district: Kokrajhar, Assam was carried out by NDFB (S) which was led by accused Jarimin @ Jirimiya Muchahary and co-accused persons namely (i) Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), (ii) Gangaraj Owary @ W. Gol @ Gangaraj Wary (A-6), (iii) Lothen Basumatary @ Borai (A-7), (iv) Swmkwr Basumatary @ B. Sukhao (A-1), (v) Rabi Basumatary @ B. Rongjabaja @ Rabi (A-2), (vi) Lwithw Brahma @ Lafa (A-3), (vii) Willbe Rabha @ R. Hasong (A-4) (viii) Jarimin, (ix) Usaobadao @ Jathi, (x) Jamphraw, (xi) Sujukhong, (xii) Jwthn @ Jailsing and other cadres. The said NDFB(S) group planned the operation and executed it as directed. Investigation has also established the conspiratorial angle of this crime from variety of sources. There was pre-meditation, common intention, meeting of minds before committing the attack, preparation for the attack, further conspiracy to destroy the evidence.
- 17.7 During the course of further investigation, sufficient credible evidence in the form of oral as well documentary prove the role of aforesaid arrested accused persons in the terrorist act at No. 3 xxxxxxxxxx village under Kokrajhar police Station, District- Kokrajhar, Assam. The evidence in the form of recovered and seized incriminating material objects from the place of occurrence i.e. seized 28 (twenty eight) nos. of empty fired cartridges and 2

(two) numbers bullet heads recovered from one dead body at the time of post mortem examination establishes the indiscriminate firing at No. 3 xxxxxxxxxx village under Kokrajhar police Station, District- Kokrajhar, Assam on 23/12/2014. For the purpose of larger conspiracy of waging war against India and also to terrorize and kill the innocent people belonging to xxxxxxxxxx community in BTAD area, the accused (i) Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), (ii) Gangaraj Ovary @ W. Gol @ Gangaraj Wary (A-6), (iii) Lothen Basumatary @ Borai (A-7) and other cadres of NDFB(S) were involved in the conspiracy and the execution of plan of killing xxxxxxxxxx people at No. 3 xxxxxxxxxx village under Kokrajhar police Station, District- Kokrajhar, Assam.

17.8 During the course of further investigation, it is revealed that, the aforesaid assailants had set the houses in the village on fire during the course of terrorist act and the physical evidence of the same in the form of the following articles was seized from the place of occurrence of the instant case:-

- (i) One half burnt wooden post of burnt house in the place of occurrence
- (ii) One partially burnt wooden plough
- (iii) One partially burnt wooden cot's one side.

The same were sent to FSL Kahilipara, Guwahati, Assam for expert opinion on the exhibits. The Expert opinion of the same was obtained in which it is opined that the exhibits were found in partially burnt condition with deposition of carbon particles.

17.9 During course of further investigation, Test Identification Parade (TIP) was conducted in Central Jail Guwahati for identification of accused persons i.e. A-5, A-6 and A-7 by a witness where the witness identified accused A-5, A-6 and A-7 as involved in the commission of crime of the instant case.

17.10 During the course of further investigation, oral evidence in the form of witnesses as well as xxxxxxxxxxxxxx also established the complicity of accused (i) Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), (ii) Gangaraj Ovary @ W. Gol @ Gangaraj Wary (A-6), (iii) Lothen Basumatary @ Borai (A-7) and other cadres of NDFB (S) in the instant crime.

17.11 The investigation in respect of other co-accused persons namely Usaobadao @ Jathi, Jamphraw, Sujukhong, Jwthn @ Jailsing and other senior leaders namely, I. K. Songbijit, G. Bidai, Batha and other members of NDFB (S) who had conspired in the instant crime and also actively participated and executed in the instant terrorist act including killing of innocent villagers of No. 3 xxxxxxxxxx village on 23.12.2014, could not be completed at this stage of investigation. Therefore, further investigation needs to be continued in the instant case u/s 173(8) Cr. PC to ascertain more evidence against the accused persons and also to arrest and prosecute other co-accused persons involved in the instant commission of crime as mentioned herein above.

17.12 Thus, the further investigation establishes the prima facie prosecutable case against the accused person namely (i) Armish Basumatary @ Aronai @ Elvis Basumatary (A-5), (ii) Gangaraj Ovary @ W. Gol @ Gangaraj Wary (A-6) and (iii) Lothen Basumatary @ Borai (A-7) who committed a terrorist act by killing 12 (twelve) people and injuring 3 (three) others with sophisticated Arms in No. 3 xxxxxxxxxx village under Kokrajhar PS, Kokrajhar District, BTAD, Assam on the fateful day on 23/12/2014. During the terrorist

act (i) Randhan Soren, 65 yrs, **(PM SL No: 1)**, (ii) Munshi Tudu, 65 yrs, **(PM SL No: 2)**, (iii) Moni Kisku, 5-7 years, **(PM SL No: 4)**, (iv) Pindru Soren, 40 years, **(PM SL No: 5)**, (v) Thakur Soren, 60 yrs, **(PM SL No: 6)**, (vi) Somila Hasda, 20 years, **(PM SL No: 7)**, (vii) Phulmoni Tudu, 70 years, **(PM SL No: 8)**, (viii) Phulmoni Soren, 36 years, **(PM SL No: 9)**, (ix) Lakhiram Kisku, 12 years, **(PM SL No: 10)** and (x) Som Hembram, 30 years, **(PM SL No: 11)** died due to firearm injuries and (xi) Karnilius Murmu, 3 years, **(PM SL No: 3)** died due to firearm/ bullet injury and (xii) Som Murmu, 50 years died due to bullet injury. Injured persons namely xxxxxxxxxxxx, age 3 years, xxxxxxxxxxxx, age 1 ½ years and xxxxxxxxxxxx, 48 years received grievous injuries caused by firearms. During the course of terrorist act, the entire village was burnt down by the aforesaid accused persons and other cadres of NDFB(S). Hence, the accused persons namely (i) Armish Basumatary @ Aronai @ Elvis Basumatary **(A-5)**, (ii) Gangaraj Owary @ W. Gol @ Gangaraj Wary **(A-6)**, (iii) Lothen Basumatary @ Borai **(A-7)** along with other co-accused members of NDFB (S), a proscribed terrorist organization under UA (P) Act, and thereby committed commission of offences as mentioned herein below.

18 CHARGE :

- **Armish Basumatary @ Aronai @ Elvis Basumatary (A-5)** for his prosecution under sections 120B, 121, 121-A, 302, 307, 436, 34 of IPC and R/W section 16, 18 and 20 of UA (P) Act & section 27 (2) (3) of Arms Act.
- **Gangaraj Owary @ W. Gol @ Gangaraj Wary (A-6)** for his prosecution under sections 120B, 121, 121-A, 302, 307, 436, 34 of IPC and R/W section 16, 18 and 20 of UA (P) Act & section 27 (2) (3) of Arms Act.
- **Lothen Basumatary @ Borai (A-7)** for his prosecution under sections 120B, 121, 121-A, 302, 307, 436, 34 of IPC and R/W section 16, 18 and 20 of UA (P) Act & section 27 (2) (3) of Arms Act.

18.1 The sanction for prosecution under Section 45(1) of The Unlawful Activities (Prevention) Act, 1967 as amended and u/s 196 of Cr.P.C. has been obtained from the competent authority and the same is enclosed herewith.

18.2 The sanction for prosecution under Section 39 of Arms Act has been obtained from the competent authority and the same is enclosed herewith.

18.3 All the aforesaid offences have been committed within the jurisdiction of this Hon'ble Court. Hence, this Hon'ble Court has got jurisdiction to try the above offences.

18.4 It is, therefore, prayed that this Hon'ble court may be pleased to take cognizance of the offences as mentioned above against the aforesaid accused persons and issue process to them to stand trial in accordance with law.
