2nd Supplementary Charge Sheet filed in case RC-03/2015/NIA/GUW

Today, (5th July 2019), National Investigation Agency(NIA) filed the 2nd Supplementary Charge Sheet against nineteen accused persons in NIA Guwahati Branch Case No. RC-03/2015/NIA/GUW (Ambush on Indian Army at Chandel). The case was re-registered by the National Investigation Agency on 07.06.2015 which had arisen out of Tengnaupal PS Case 14(6)/2015 dated 04.06.2015. In pursuance of a conspiracy hatched by the senior leaders, a group of 20 armed cadres belonging to three banned terrorist organizations, namely KCP(Noyon Faction), NSCN(Khaplang Faction) and KYKL, equipped with sophisticated arms, ammunitions and explosives laid an ambush on the convoy of 6th Dogra Regiment of the Indian Army in the early morning of 04.06.2015 at Paraolon village under Chandel District, in which 18 security personnel were killed and 15 others were grievously injured.

2. Investigation in the case established that senior leaders and cadres of the above mentioned banned organizations were involved in the conspiring and the commission of the heinous crime. Out of these 5 (Five) accused persons have already been arrested and chargesheeted on 19.12.2015 and 09.07.2018.

3. ★ Accused Laishram Anand Meitei @ Laishram Anand Singh @ Sana, aged around 27 years, S/o Late Laishram Rajen Meitei, a resident of Village Chajing Karam Makha Leikai, PO & PS Singjamei, Distt. Imphal West, Manipur, was arrested on 10.01.2019 in connection with this case. On completion of the investigation, the said accused person along with other 18(eighteen) absconding accused persons have been charge-sheeted vide 2nd Supplementary Charge-Sheet dated 05.07.2019, for their role and involvement in the crime, as mentioned hereunder against their names :-
