NIA Special Court, Patiala House, New Delhi Pronounces Sentence Against 5 Accused in ISIS Roorkee Module Case (RC - 09/2016/NIA/DLI)

Today (02.06.2022), NIA Special Court, Patiala House, New Delhi pronounced sentence convicting five (05) accused under various sections of UA(P)A, IPC and Explosive Substances Act, as detailed below, -

i) Akhlakur Rehman @ Akhlaq s/o Md. Naseem r/o Mohalla Teliwala, Dabur Wali Masjid, Village Bhagwanpur, Chandanpur, PS Mangalore, Distt. Haridwar, Uttrakhand sentenced to 07 years of RI and fine under section 18, 20, 23 of UA(P) Act, 05 years RI and fine under section 120B of IPC, 05 years of RI and fine under section 4(b), 5 of Explosives Substances Act r/w 120B of IPC.

ii) Md. Azeemushan s/o Sh. Abdul Sattar, r/o H. No. 1661, Mohalla Bhari ila, Rustam Wali Gali, Landhaura, Distt. Haridwar, Uttrakhand sentenced to 07 years of RI and fine under section 18, 20, 23 of UA(P) Act, 05 years RI and fine under section 120B of IPC, 07 years of RI and fine under section 4(b), 5 of Explosives Substances Act r/w 120B of IPC.

iii) Md. Meraj @ Monu s/o Sh. Tazammul Hussain, r/o Near Nagar Palika Office, Luxar Road, Village & PO Landhaura, PS Mangalore, Distt. Haridwar, Uttrakhand sentenced to 07 years of RI and fine under section 18, 20, 23 of UA(P) Act, 05 years RI and fine under section 120B of IPC, 05 years of RI and fine under section 4(b), 5 of Explosives Substances Act r/w 120B of IPC.

iv) Md. Osama @ Adil @ Peer s/o Sh. Nafiz Ahmed, r/o Village Zorasi, Landhaura, District Haridwar, Uttrakhand sentenced to 07 years of RI and fine under section 18, 20, 23 of UA(P) Act, 05 years RI and fine under section 120B of IPC, 05 years of RI and fine under section 4(b), 5 of Explosives Substances Act r/w 120B of IPC.

v) Mohsin Ibrahim Sayyed s/o Sh. Sayyed Ibrahim r/o Room No. D-8, Malwani, Malad West, Mumbai sentenced to 07 years of RI and fine under section 17, 18, 20 of UA(P) Act, 05 years RI and fine under section 120B of IPC.

2. The case pertains to the conspiracy hatched by a foreign based ISIS handler Yousuf Al-Hindi (since dead) in connivance with the above accused persons to carry out a terrorist activity in the area of Delhi / NCR and by planting IEDs during the Ardh Kumbh festival in Haridwar, Uttarakhand and for this they were in the process of acquiring explosives & necessary expertise in assembling IEDs. The case was initially registered by Special Cell, Delhi Police vide FIR No. 05/2016 dated 18.01.2016 and re-registered by NIA on 18.03.2016. After the investigation of the case, charge-sheet was filed against six (06) accused persons including the above mentioned five (05) accused persons. The accused persons had pleaded guilty before the Hon'ble court and were convicted on 20.05.2022
