NIA Files Charge Sheet Against 04 Accused in Conspiracy of Killing a Hindu Priest by operatives of Khalistan Tiger Force in Jalandhar Case (RC-27/ 2021/NIA/DLI)

On 04.07.2022, NIA filed Charge-Sheet before NIA Special Court, Mohali against 04 accused persons in RC-27/2021/NIA/DLI.

2. The case pertains to attack on a priest Kamaldeep Sharma at village Bhar Singh Pura, Phillaur, District Jalandhar by accused Kamaljeet Sharma @ Kamal and Ram Singh @ Sona on the directions of Canada based accused persons namely Arshdeep Singh @ Arsh @ Prabh and Hardeep Singh Nijjar. The case was initially registered as FIR No. 28/2021 dated 31.01.2021 at PS Phillaur, District Jalandhar Rural and re-registered by NIA on 08.10.2021.

3. Investigations have revealed the entire conspiracy was hatched by accused Arshdeep Singh @ Arsh @ Prabh and Hardeep Singh Nijjar, both based in Canada, to disturb peace and disrupt the communal harmony in Punjab by killing a Hindu Priest. The arrested accused Kamaljeet Sharma and Ram Singh @ Sona had shot at the victim Kamaldeep Sharma, on the directions of Canada based Arshdeep Singh @ Arsh.

4. Based on thorough investigations conducted by NIA, the following four accused have been chargesheeted under various sections of laws as given below :

- i. Hardeep Singh Nijjar S/o Piara Singh R/o Village Bhar Singh Pura, District Jalandhar, Punjab, presently residing at 12551, 89-A AVE, Surrey, BC-1A9, Canada u/s 120B r/w 307 of IPC, sections 16, 17, 18, 18B & 20 of UA (P) Act.
- ii. Arshdeep Singh @ Arsh @ Prabh S/o Charanjit Singh R/o Village Dala, PS Mehna, District Moga, (Punjab) u/s 120B r/w 307 of IPC, sections 16, 17, 18, 18B, 21 & 23 of UA (P) Act.
- iii. Kamaljeet Sharma @ Kamal S/o Darshan Sharma R/o Village Dala, PS Mehna, District Moga, (Punjab) u/s 120B & 307 of IPC, sections 16, 17, 18, 18B, 21 & 23 of UA (P) Act, section 27 (1) of Arms Act.
- iv. Ram Singh @ Sona S/o Ranjit Singh R/o Village Ghall Khurd, PS Ghall Khurd, District Ferozepur u/s 120B, 201 & 307 of IPC, sections 16, 17, 18, 20, 21 & 23 of UA (P) Act, section 27 (1) of Arms Act.

5. Further investigations in the case are in progress.
