S.O. 989(E).—In exercise of the powers conferred by sub-section (1) of Section 11 of the National Investigation Agency Act, 2008 (34 of 2008), the Central Government hereby notifies the Court of Principal Judge, City Civil and Sessions Courts, Ahmedabad, as the Special Court for purposes of the said sub-section (1) of Section 11 of the said Act for the trial of Scheduled Offences.

2. The jurisdiction of the Special Court mentioned above shall extend throughout the entire territory of State of Gujarat.

NOTIFICATION

New Delhi, the 27th November, 2014

S.O. 3003(E).—Whereas, in exercise of the powers conferred by sub-section (1) of Section 11 of the National Investigation Agency Act, 2008 (34 of 2008) (hereinafter referred to as the said Act), the Central Government had, vide notification number S.O. 989 (E), dated the 30th April, 2012, published in the Gazette of India, Extraordinary, Part-II, Section 3, Sub-section (ii), dated the 2nd May, 2012, notified the Court of Principal Judge, City Civil and Sessions Court, Ahmedabad as the Special Court for the purpose of sub-section (1) of section 11 of the said Act having Jurisdiction throughout the territory of State of Gujarat for the trial of Scheduled Offences;

And whereas, Shri K. K. Bhatt, Principal Judge, City Civil and Sessions Court, Ahmedabad, who was appointed as the Judge to preside over the said Special Court vide notification number S. O. 1075 (E), dated 11th April, 2014, published in the Gazette of India, Extraordinary, Part-II, Section 3, Sub-section (ii), dated the 11th April, 2014, has retired from service on the 30th September, 2014 after attaining the age of superannuation;

Now, therefore, in exercise of the powers conferred by sub-section (3) of section 11 of the said Act and in supersession of the notification number S. O. 1075 (E), dated 11th April, 2014, except as respects things done or omitted to be done before such supersession, the Central Government, on the recommendation of the Hon'ble Acting Chief Justice of the High Court of Gujarat, hereby appoints Shri P. B. Desai, Principal Judge, City Civil and Sessions Court, Ahmedabad as the Judge to preside over the said Special Court.
