3. (a) **Suspected Offence:**

On 27.07.2019, information was received at Nagarnar, Police station that a group of Cadres of CPI (Maoist) had gathered near village Tiriya with the intention to perpetrate a big incident on 28.07.2019 during Shaheed Diwas. During search operation, exchange of fire ensued between the cadres of CPI (Maoist) and a combined team of local District Reserve Guard, Special Task Force and CRPF, resulting in the killing of six Maoists and one civilian. Police party recovered arms and ammunition and other incriminating materials from the scene of crime. A FIR No. 179/2019 dated 28.07.2019 was registered in this regard at PS Nagarnar, District Bastar, Chhattisgarh.

The Central Government has received information regarding the registration of an FIR no. 179/2019 dated 28.07.2019 at PS- Nagarnar, District- Bastar,

Chhattisgarh under sections 147, 148, 149, 302, 307 of IPC, sections 38(2) & 39(2) of UA(P) Act 1967 and sections 25 & 27 of Arms Act, relating to exchange of fire between the cadres of CPI (Maoist) and a combined team of local District Reserve Guard, Special Task Force and CRPF, resulting in the killing of six Maoists and one civilian.

The Group of Cadres of CPI (Maoist) had gathered near village Tiriya with the intention to perpetrate a big incident on 28.07.2019 during Shaheed Diwas.

The Police party recovered arms and ammunition including (i) 303 rifles-02 (ii) 303 (P-14) rifles-02 (iii) INSAS rifle-01 (iv) Barmar rifle-01 (v) Magazine-03 and (vi) 56 rounds along with several incriminating materials from the scene.




