The information was received by PS Phillaur, Jalandhar that two unknown persons have attacked on Hindu priests Shri Kamaldeep Sharma and Smt. Simranjit Kaur in Phillaur. It emerged during investigation that they were targeted on the directions of Hardeep Singh Nijjar of terror outfit Khalistan Tiger Force (KTF), to attack prominent persons of other faiths to create a sense of fear and disharmony in the society.

Whereas, the Central Government has received information regarding registration the case FIR no 28 dated 31.01.2021 at PS Phillaur, District Jalandhar Rural, Punjab

under sections 307 & 34 of IPC and sections 25 & 27 of Arms Act, 1959 and subsequently added sections 10, 11, and 13 of the Unlawful Activities (Prevention) Act, 1967 relating to firing on Shri Kamaldeep Sharma and Smt. Simranjit Kaur, Sewadars of mandir, by two youth who had their face covered with mufflers on 31.01.2021 at about 09:40 AM.

And whereas, upon preliminary enquiry, it was revealed that on the directions of Hardeep Singh Nijar, Chief of Khalistan Tiger Force, the Punjab based shooters from the gang, namely, Lovepreet @ Ravi S/o Jagjit Singh R/o Dala, Mehna, Moga, Kamaljit Sharma @ Kamal S/o Darshan Singh R/o Dala, Mehna Moga and Ram Singh @ Sona S/o Ranjit Singh R/o Ghalkhurd, Ferozpur, Punjab, targeted prominent persons of other faiths to create a sense of fear and disharmony in the society.

The Central Government is of the opinion that a Scheduled Offence under the NIA Act 2008 has been committed and having regard to the gravity of the offence and its ramifications on national security, the case is required to be investigated by the NIA in accordance with the NIA Act, 2008.


The Government of India, Ministry of Home Affairs, CTCR Division, North Block, New Delhi, vide its Order F. No. 11011/62/2021/NIA dated 05.10.2021, issued as per provision of sub-section (4) of section 6 read with section 8 of the National Investigation Agency Act, 2008, has directed the National Investigation Agency to take up the investigation of the FIR No. 28 dated 31.01.2021 at PS Phillaur, District Jalandhar Rural, Punjab.

The MHA order no. 11011/62/2021/NIA dated 05.10.2021 and copy of FIR no. 28 dated 31.01.2021 of PS Phillaur, District Jalandhar Rural, Punjab are enclosed herewith as Annexure 'A' & 'B'.
